1. I agree to pay a breeding fee of \$800.00 plus GST of which \$100.00 plus GST is a non-refundable booking fee payable upon the execution of this contract. The balance plus all expenses including mare care is payable when mare is pronounced safe in foal or when mare leaves Wildwood Reining Horses after being exposed to stallion. Any additional veterinary fees will be billed directly. No Breeder's Certificates will be issued until all charges are paid.
2. Wildwood Reining Horses agrees to provide suitable facilities for the care and feed of the mare and/or foal while in its custody. Mare owner agrees to the following rates: \$10.00/day plus GST for dry mares or \$12/day plus GST for wet mares.
3. I expect that Wildwood Reining Horses will use reasonable efforts to settle the mare between the dates of March 1, 2010 and July 15, 2010. Should I fail to deliver the mare for breeding on or before July 15, 2010, Wildwood Reining Horses shall be under no further obligation to this contract.
4. I represent and warrant that the mare to be bred is **halter broken, healthy and in sound breeding condition, free from infections and contagious or transmissible disease**. Stallion owner reserves the right to refuse to accept any mare which is not in sound breeding condition.
5. Wildwood Reining Horses may exercise its own judgment in caring for and supervising the mare and/or foal. Wildwood Reining Horses or veterinarian may perform at absolute discretion such veterinary services as deemed necessary or appropriate at my expense. These include but are not limited to worming, treating for infections, disease or accident-related conditions, preventative measure, original examination or pregnancy checking.
6. Wildwood Reining Horses, the stallion owner, and any other parties involved shall be saved harmless of liability for any loss from fire, theft, sickness, disease, injury, death or other harm suffered by mare and/or foal. Likewise Wildwood Reining Horses assumes no liability for injury, sickness, or death of the stallion, owners or employees caused by my mare and/or foal.
7. If the mare does not settle or does not produce a "live foal" (one that stands and sucks), I shall be entitled to return the mare for breeding the following year on the terms and conditions provided in the agreement without payment of any further breeding fee, but upon payment of board, handling fee and other expenses. It is agreed that this provision will be of no further effect if the mare is taken to any other stallion before returning the above-named stallion **or does not produce a live foal after the second season**. If the stallion should die or become unfit for service before the terms of this contract are satisfied, the breeding fee, less the booking fee

shall be refunded to me by stallion owner within a reasonable time of receipt by Wildwood Reining Horses of a veterinarian's certificate stating the mare is barren or did not produce a live foal.

8. A photocopy of the Mare's papers showing both sides must be furnished and returned with this contract.
9. When Wildwood Reining Horses signs and returns a copy of this contract to me, it will become the binding contract of both parties. This contract is not transferable or assignable.
10. I agree to have my mare current on vaccinations and worming and free of external parasites before delivery to Wildwood Reining Horses. I certify that my mare has not had strangles in the last 90 days before delivery to Wildwood Reining Horses. Should she develop this condition after the handling fee has been paid, I have the right to delay this agreement to the following season under the same terms and conditions as provided in the agreement.
